B. Pisetner, parent, spoke on behalf of K. Savino stated that he was a teacher for 30 years, then a religious school administrator and was impressed by Ms. Savino's professionalism, caring and methodology and could not understand why not hired unless it was an honest mistake.

K. Mitchell, prior teacher, spoke on behalf K. Savino. It is her position before she resigned that Ms. Savino had applied. Ms. Savino had been her co-teacher, collaboration with her has been the key to the student's success, she loves what she does and has been a fantastic teacher. She requested the Board reconsider.
