## New Jersey School Board Presentation

Ms. Walters provided a presentation new to New Jersey School Boards Association highlighting the eight characteristics of highly effective boards. The presentation also touched on social media and effective communication with the public.

#### 2019-2020 Budget Overview

Mr. Pruitt and Mrs. Weeks provided an overview of the financial status of the district looking forward through the impact of S2 which is expected to reduce state aid.

The overview included a discussion on School Funding Reform Act and its impact on calculating state aid, district enrollment and staffing changes, Staffing and total Cost Per pupil ratios from the Tax Payer spending guide, historical perspective of tax levy and tax rate, the projection of state aid under S2, projection of tax levy, state aid and fund balance through the implementation of S2, budget projections and projected budget at cap using banked cap, budget components, discussion on banked cap, and projected impact on tax rate for the general fund budget and a reminder that debt is being transferred to the school which will impact the 2019 tax rate.
